"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north side of Edgement Avenue in a subdivision known as Riverside, and being known and designated at Lot No. 6 of blook "N ", according to a plat of Riverside prepared by P. B. Foster October 1909, said plat being recorded in the Rinc office for & Greenville County in Plat Book A, pages 322 and 323, and having the following metes and bounds according to said plat:
