All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accredit interest, shall become 'immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgager promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That the said mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said LIBERTY LIFE INSURANCE COMPANY according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to the said mortgagor in hand well and truly paid by the said LIBERTY LIFE INSURANCE COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release unto the said LIBERTY LIFE INSURANCE COMPANY, its successors and assigns, forever:

ALL that lot of land situate on the East side of Industrial Drive and on the West side of the right of way of the Charleston & Western Carolina Railroad, part of Pleasantburg Industrial Park, near the City of Greenville in Greenville County, S. C. and having, according to a survey made by Piedmont Engineering Service, October 18, 1961, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book ZZ at Page 79, which plat was revised June 22, 1962.

BEGINNING at an iron pin on the Bast side of Industrial Drive, said pin being where the Bast side of Industrial Drive intersects with the West side of the right of way of the Charleston & Western Carolina Railroad and runs thence along the right of way of said railroad, S. 37-10 B., '542.4 feet to an iron pin; thence S. 52-50 W., 245.5 feet to an iron pin on the Bast side of Industrial Drive; thence along the curve of Industrial Drive (the chord being N. 23-39 W., 84.3 feet) to an iron pin; thence still with the curve of Industrial Drive (the chord being N. 18-18 W., 78.3 feet) to an iron pin; thence still with the curve of Industrial Drive (the chord being N. 5-44 W., 57.4 feet); thence still with the curve of said Drive (the chord being M. 6-48 W., 256.3 feet) to an iron pin; thence still with the curve of Industrial Drive (the chord being M. 17-45 W., 123.3 feet) to the beginning corner.
