KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by file Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by the presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate. It is and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 17, as shown on plat of property of J. Cleo Roper, recorded in the R. M. C. Office for Greenville County, in Plat Book "PP", at Page 133, and, according to a recent survey by T. C. Adams, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 17 and 18, on the northeastern side of West Gantt Circle, which iron pin is 742. 4 feet northwest of Grove Road, and running thence with the northeastern side of West Gantt Circle, N. 66-30 W. 85 feet to an iron pin at the joint front corner of Lots Nos. 16 and 17, thence with the line of Lot No. 16, N. 23-30 E., 175.5 feet to an iron pin at the joint rear corner of Lots Nos. 16 and 17; thence S. 64-24 E., 85.06 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence with the line of Lot No. 18, S. 23-30 W., 172. 2 feet to an iron pin on the northeastern side of West Gantt Circle, at the joint front corner of Lots Nos. 17 and 18, the point of beginning.
