All that lot of land with the buildings and improvements thereon situate on the East side of Sevier Street in the City of Greenville, in Greenville County, South Carolina, being shown as Lot #57 on plat of ark Hill made by Dalton & Neves, Engineers, May, 1940, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "J, pages 208 and 209; said lot fronting 75.7 feet along the East side of Sevier Street, running back to a depth of 169.3 feet on the North side; to a depth of 168.9 feet on the South side and being 76 feet across the rear.

Should the Veterans' Administration fail or refuse to issue its guaranty of the loan secured by this instrument under the provisions of the Servicemen's Readjustment Act of 1944, as amended, within sixty days from the date the loan would normally become eligible for such guaranty, the mortgage herein may, at its option, declare all sums secured hereby immediately due, and payable.
