Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the seeing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagoe, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land*with the buildings and improvements thereon situate on the Northeast side of Homestead Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 17 on Plat No. 1 of Homestead Acres made by J. Mac. Richardson, Surveyor, November, 1959, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book RR, Page 35, said lot fronting 90 feet along the Northeast side of Homestead Drive and running back to a depth of 120 feet on the Southeast side; to a depth of 120 feet on the Northwest side and being 131.2 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
