"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, on the Northeast side of a County road leading to Columbia Baptist Church, containing 1.26 acres, more or less, shown on plat by John C. Smith and J. Coke Smith, August 17, 1949, described as follows: BEGINNING at iron pin on Northeast side of said road, in corner of property of Dr. G. L. Martin, thence along line of said property South 52-30 East 475 feet to iron pin, corner of property of James A. Scott, thence South 51 45 West 233 feet to iron pin in edge of said road on line of McCullough, thence along said road and McCullough property North 24 West 475 feet to the beginning.

Collins, thence North 79-35 East 543.5 feet to iron pipe at line of property of Estate of Fred McCullough, thence along line of said Estate, South 9 West 812.5 feet to stake, thence South 69 West 23.5 feet to point in center of said highway, thence along center of said highway North 28-15 West 812.5 feet to point in center of said highway, the beginning.
