and truly indebted unto the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of

Fourteen thousand Five hundred and no/100- - (\$ 11r,500.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of
