Mac Richardson, November 1959, recorded in the R.M.C. Office for Greenville County in Plat Book RR, at Page 35 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Havenhurst Drive; joint front corner of Lots 37 and 38; thence with the joint line of said lots, S. 24-25 E. 216.2 feet to an iron pin in the line of Lot 31; thence with the rear lines of Lots 31 and 32, N. 65-00 E. 78 feet to an iron pin at the joint rear corner of Lots 36 and 37; thence with the joint line of said lots, N. 15-01 W. 265 feet to an iron pin on the southern side of said Havenhurst Drive; thence with the southern side of said Havenhurst Drive; thence with the southern side of said Havenhurst Drive, S. 47-39 W. 100 feet to an iron pin; thence continuing still with the southern side of said Havenhurst Drive, S. 34-50 W. 30 feet to the point of beginning; being the same conveyed to us by Allen E. Vaughn by deed of even date to be recorded herewith."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree(s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes; and assessments next due on the mortgaged property all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments. Should these payments exceed the

amount of payments actually made by the mortgagee for taxes, assessments, or insurance premiums, the excess may be credited by the mortgagee on subsequent payments to be made by the mortgagor(s) if, however, said sums shall be insufficient to make said payments when the same shall become due and payable, the mortgagor(s) shall pay to the mortgagee any amounts necessary to make up the deficiency.
