NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the western side of Wilmington Road, near the City of Greenville, being shown as lot 159, on plat of Sector III of Botany Woods, recorded in Plat Book RR at Page 37, and described as follows:

BEGINNING at an iron pin on the western side of Wilmington Road, at the corner of lot 158, and running thence with the curve of the western side of said road, the chord of which is S. 9-07 B. 125 feet to iron pin at the corner of lot 160; thence with the line of said lot, S. 77-45 W. 211 feet to iron pin in line of lot 168; thence with the line of lot 168, N. 10-37 W. 45.7 feet to iron pin at the corner of lot 170; thence with the line of said lot, N. 14-09 W. 39.3 feet to iron pin, corner of lot 158; thence with the line of said lot, N. 67-13 E. 222 feet to the point of beginning.
