NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well, and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the north side of Hubert Street in the City of Green, designated as the property of Willton. Oliver according to survey and plat thoreof by H.S. Brockman, Surveyor, dated January 21, 1950, and having the following courses and distances, to-wit:

southeast corner of said lot, also corner of P.W. Wilbanks lot and being 209.5 feet westward from the intersection of Hubert Street and South Avenue, pin being set 3 feet northward from Street margin, and running thence along the line of P.W. Wilbanks and G.V. Hannah, N. 19-12 E. 180 feet to an iron pin on line of Mrs. G.D. McMillan's lot; thence along the line of the McMillan lot and lot of J.B. Mendenhall Estate, N. 69-07 W. 80 feet to iron pin, corner of Mrs. Reeves' lot; thence along the line of the Reeves' lot, S. 19-12 W. 180 feet to an iron pin on edge of sidwalk 3.74 feet from margin of Hubert Street; thence along the sidwalk of said Hubert Street, S. 69-07 E. 80 feet to the beginning corner.
