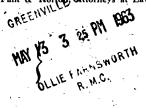

ALL that piece, parcel or tract of land with all buildings and improvements thereon, situate, lying and being in O'Neal Township, Greenville County, State of South Carolina, containing approximately two acres, more or less, having the following description:

BEGINNING at a corner on the Meece Bridge Road, corner of land, former y T. R. Fowler Estate, running thence N. 79-05 E. 435.6 feet to an iron pin; thence S. 1-25 E. 200 feet to an iron pin; thence S. 79-05 W. 435.6 feet to a point in Meece Bridge Road; thence N. 1-25 W. 200 feet to point of beginning.
