To All Whom These Presents May Concern:

W. E. Shaw, Inc., a South Carolina corporation with its principal place of business

in Greenville, South Cardina,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgoor(s) in and by my/our certain promissary note, in writing of even date with these presents am/are well and truly debted to FIRST FEDERAL SAVINGS LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Nine Thousand, Six Hundred Fity and no 100 (\$ 9.550.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Sixty-Two and 19/100-----(\$ 62.19) Bollars upon the first day of each and every calendar month hereafter in advance, until the full principal sam, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if the paid earlier and if not subsequently

extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the simulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per consum attorney's fee beside all costs and expenses of collection to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection or if said debt or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of whire is secured under this mortgage); and in and by the form of the payable and the collected by an attorney for being thereunto had, will more fully appear.

NOW NOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and riso in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly past by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the saming of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and releaser, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements: thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 49 of a subdivision known as Avon Park as shown on plat thereof prepared by C. C. Jones, December 1956, recorded in the R. M. C. Office for Greenville County in Plan Book KK, at Page 11, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of Sheffield Lane, joint front corner of Lots Nos. 49 and 72, and running thence along the joint line of said lots, S. 11-43 W. 175 feet to an iron pin on the line of Lot No. 50; thence along the line of that lot, N. 73-32 W. 102.6 feet to an iron pin on the southeastern side of Thames Drive; thence along the southeastern side of Thames Drive, N. 15-53 E. 140 feet to an iron pin; thence following the curvature of Thames Drive as it intersects with Sheffield Lane, the chord being N. 58-48 E. 39.4 feet to an iron pin on the southwestern side of Sheffield Lane; thence along the southwestern side of Sheffield Lane, S. 78-17 II. 65 feet to the beginning corner; being the same conveyed to the mortgagor corporation under its former name of Leslie & Shaw, Inc. by W. A. Floyd by deed dated February 7, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 719, at Page 94.
