C., (hereinalter referred to as Mortgagor) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of --- Twenty Two Thousand and No/100---

DOLLARS (\$ 22,000.00 , ), with interest thereon from date at the rate of Pive & One-Half per contum per annum, said principal and interest to be repaid in monthly instalments of One Hundred

NOW KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to accure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor in any time to advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Thire Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, cold and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, attuate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, being known and designated as lots 4 and 5 of Block L, as shown on the plat of Highland Terrace, recorded in Plat Book D at Pages 238 and 239, and also lot 2 as shown on a subdivision for C. C. Hindman, et al recorded in Plat Book DD at Page 77, a composite description of the three lots being as follows:

BECINNING at an iron pin on the north side of Montglair Avenue (formerly fairview Avenue), which pin is 190 feet west of the intersection of Montclair Avenue and North Main Street, and is the joint corner of lots 1 and 4 of Block L as shown on the Highland Terrace Plat, and running along the rear line of lots 1, 2 and 3 of said plat N. 14-47 B. 200 feet to an iron pin in the south side of a 15 foot alley, as shown on the Hindman plat above referred to; thence with the south side of said alley 5. 82-28 W. 109 feet to an iron pin in the rear corner of lot 6; Block L, on the Highland Terrace Plat; thence with line of said lot, S. 21-03 W. 150.2 feet to an iron pin on the north side of Montclair Avenue; thence with said Avenue, S. 70-47 B. 105.5 feet to the point of beginning.
