All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Kingswood Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as major portion of Lot No. 54 as shown on a plat of Shamrock Acres, prepared by Clifford C. Jones, R.L.S., dated September, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at page 43, and having according to a plat prepared by C. C.
