All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Mauldin and shown as Lot 180 on a plat of Pine Ferest, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book QQ\*, Pages 106-107, and having according to said plat the following metes and bounds, to-wit:
