ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying end being in the State of South Carolina, County of Greenville, Highland Township, Said State and County, on the North side of Few, sichapel, being known and designated as the greater part of Lot #2, on plat of property of W.H. Campbell, J.2. Bruce Surveyor April 19, 1957, recorded in plat book Vol. NN at page 63 and having the following metes and bounds, to -wit:
