C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, and being lot No. Ninty-four (94), and all improvements thereon, on the southern side of Chestnut Avenue, on plat of Burgiss Hills, recorded in R.
