"All that certain piece, parcel or lot of land, with all improvements thereon, or begenfter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenviller Oneal Township, on the north side of the Cunningham Lake (Green Reservoir), containing 93/100 of an acres, more or less, and having the following courses and distances, to-wit:

BEGINFING at an iron pin in old road and south side of new road that leads to Mosteller Mill and running thence 3: 73-15 W. 200 feet to an iron pin on property line of Cunningham Lake; thence along said lake, S. 54-58 E: 75 feet to an iron pin; thence S. 44-38 E. 181 feet to an iron pin; thence S. 31-38 E: 45 feet to iron pin; thence leaving lake, N. 53-30 E. 160.7 feet to an iron pin on the right-of-way line of road; thence along road, N. 42-15 W. 226 feet to the/beginning corner.
