NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Avon Drive, shown as Lot 30 on plat of Avon Park, recorded in the R.M.C. Office for Greenville County in Plat Book KK at Page 71, and having according to said plat the following metes and bounds, to wit:

"BEGINNING at an iron pin on the eastern side of Avon Drive, corner of Lot 31, and running thence with line of said lot N. 79-05 E. 714.6 feet to iron pin in line of Lot 37; thence with line of Lots 37 and 38, N. 24-14 W. 66 feet to iron pin, corner of Lot 29; thence with line of said lot N. 84-18 W. 190 feet to iron pin on the eastern side of Avon Drive; thence with the eastern side of Avon Drive S. 5-42 W. 16.4 feet to iron pin; thence S. 1-37 W. 43.5 feet to iron pin; thence S. 8-05 E. 60 feet to the point of beginning."
