WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the southern side of Overbrook Road, in the City of Greenville, being lot # 10 and the adjoining one-half of lot # 11, as shown on plat of the subdivision of Tract # 1 of Overbrook Land Company, recorded in Plat Book K at Page 59, and described as follows:

BEGINNING at a stake on the southern side of Overbrook Road, 80 feet East from Brookside Avenue, and running thence with the southern side of said road, N. 72-11 E. 90 feet to a stake; corner of lot 9; thence with the line of said lot, S. 17-49 E. 150 feet to a stake; thence S. 72-11 W. 90 feet to a stake; thence N. 17-49 W. 150 feet to the point of beginning.
