NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroling, County of

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the northeastern corner of McCrary and Herbert Streets and being known and designated as Lot No. 31 of Elizabeth Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "F", at Page 298 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake at the northeastern corner of McCrary and Herbert Streets and running thence with the eastern side of Herbert Street N. 13-45 E. 150 feet to a stake at the corner of Lot No. 42; thence with the line of said lot S. 76-15 E. 50 feet to a stake at the corner of Lot No. 32; thence with the line of said lot S. 13-45 W. 150 feet to a stake on McCrary Street; thence with the north side of McCrary Street N. 76-15 W. 50 feet to the point of beginning.

The above is the same property conveyed to the mortgagor by deed recorded in Deed Book 582, at Page 207.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant, and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
