That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about one-half mile west of Milford Baptist Church and about the City of Green, lying on the south side of the Milford Church Road, and having the following courses and distances, to-wit:

BEGITTING on a nail in the center of said road (old iron pin on south bank thereof at 22 feet), corner with McPherson, and runs thence S. 4-15 E. 684.7 feet to old stone corner; thence S. 7-10 W. 308.5 feet to an iron pin; thence N. 76-05 W. 320 feet to a stake; thence N. 0-45 E. 924.3 feet to a nail in the center of said road (old iron pin corner on bank at 31 feet); thence along and with the center of said road, S. E7-06 E. 284.2 feet to the beginningcorner, containing 6.98 acres, more or less, bounded by lands of McPherson, Homer Harbin, and btiers.
