C. Jones, C. E., September 6, 1963 to be recorded herewith and having, according to the last mentioned plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwestern side of Clemson Avenue at the joint front corner Lots Nos. 26 and 27 and running thence with the joint line of said lots, N. 56-40 W. 160 feet to an iron pin on the southeastern side of Trotter Street; thence with the southeastern side of said Trotter Street, N. 33-20 E. 93.3 feet to an iron pin in the line of Lot No. 25; thencé along a line through Lot No. 25, S. 56-40 E. 160 feet to an iron pin on the northwestern side of Clemson Avenue; thence with the northwestern side of said Clemson Avenue, S. 33-20 W. 93.3 feet to the point of beginning; being the same conveyed to the mortgagor corporation by Greenville Land Co., Inc. by deed dated November 22, 1963 to be recorded herewith."
