NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on West McBee Avenue, in the City of Greenville, and having the following metes and bounds, to wit:

"BEGINNING at a stake on said Avenue at corner of lot now or formerly belonging to Goddard; thence with said West McBee Avenue, S. 70°45' East 47 feet to stake at corner of property now or formerly of First Baptist Church; thence N. 19 1/2 E. 100 feet to stake; thence N. 70° 45' W. 38 feet to a stake on line of property now or formerly of Goddard; thence S. 22° 45' W. 100 feet to the beginning corner."
