WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & DOAN ASSOCIATION OF GREEN-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

One Hundred Three and 09/100-----(\$ 103.09) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's feesible all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION-OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and peleased, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"BEGINNING at a point on the easterly side of Dexter Drive, joint front corner of Lots 40 and 41 and running thence along the easterly side of Dexter Drive, N. 8-32 W. 115.0 feet to a point, joint front corner of Lots 41 and 42; thence turning and running along the common boundary of said lots, N. 83-20 E. 175.1 feet to an iron-pin, in the rear line of Lot 61, joint rear corner of Lots 41 and 42; thence turning and running along the rear line of Lots 61 and 62, S. 8-28 E. 105.0 feet to a point, joint rear corner of Lots 41 and 40; thence turning and running along the common boundary of Lots 41 and 40, S. 80-0 W. 175.0 feet to the point of beginning; being the same conveyed to me by Drexel, Inc. by deed dated December 13, 1963, to be recorded herewith."
