TO ALL WHOM THESE PRESENTS MAY CONCERN:

WE, STEVE H. DRAGON AND MARJORIE L. DRAGON,

SEND GREETING:

WHEREAS, WE the said STEVE H. DRAGON AND MARJORIE L. DRAGON,

in and by OUR certain promissory note in writing, of even date with these Presents ARE well and truly indebted to CAMERON-BROWN COMPANY, a corporation chartered under the laws of the State of North Carolina, in the full and just sum of FOURTEEN THOUSAND AND NO/100 (\$14,000.00) DOLLARS, to be paid at its office in Raleigh, N. C., or at such other place as the holder of the note may from time to time designate in writing, with interest thereon from date hereof until maturity at the rate of FIVE AND ONE-HALF (5 1/2 %) per centum per annum, said principal and interest being payable in MONTHLY instalments as follows: Beginning on the 1ST day of MAY, 1964, and on the 1ST day of each MONTH of each year thereafter the sum of \$114.52 to be applied on the interest and principal of said note, the unpaid balance of said principal and interest to be due and payable on the 1ST day of APRIL, 1979; the aforesaid MONTHLY payments of \$114.52 each are to be applied first to interest at the rate of FIVE AND ONE-HALF (5 1/2 %) per centum per annum on the principal sum of \$14,000.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each MONTHLY payment shall be applied on account of principal.

All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That WE, the said STEVE H. DRAGON AND MARJORIE L. DRAGON, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CAMERON-BROWN COMPANY, according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to US the said STEVE H. DRAGON AND MARJORIE L. DRAGON in hand well and truly paid by the said CAMERON-BROWN COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CAMERON-BROWN COMPANY.

ALL THAT PIECE, PARCEL, OR LOT OF LAND SITUATE, LYING AND BEING ON THE WESTERN SIDE OF WELLINGTON LANE (FORMERLY CORA LANE) IN GREENVILLE COUNTY, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT 98 ON A PLAT OF "ADDITION TO WELLINGTON GREEN" RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK RR AT PAGE 99, AND HAVING, ACCORDING TO A MORE RECENT SURVEY AND PLAT ENTITLED "PROPERTY OF STEVE H. & MARJORIE L. DRAGON", DATED MARCH 11, 1964, PREPARED BY R. B. BRUCE, R.L.S., THE FOLLOWING METES AND BOUNDS:

BEGINNING AT A POINT ON WELLINGTON LANE AT THE JOINT FRONT CORNER OF LOTS 98 AND 99 AND RUNNING THENCE ALONG THE EDGE OF WELLINGTON LANE S. 5-34 W. 100 FEET TO A POINT; THENCE N. 85-35 W. 155.6 FEET TO A POINT; THENCE N. 0-30 E. 100 FEET TO A POINT; THENCE S. 85-40 E. 164.4 FEET TO THE BEGINNING CORNER.

THE MORTGAGOR AGREES THAT THERE SHALL BE ADDED TO EACH MONTHLY PAYMENT REQUIRED HEREUNDER OR UNDER THE EVIDENCE OF DEBT SECURED HEREBY, AN AMOUNT ESTIMATED BY THE MORTGAGEE TO BE SUFFICIENT TO ENABLE THE MORTGAGEE TO PAY AS THEY BECOME DUE, ALL TAXES, ASSESSMENTS, HAZARD INSURANCE PREMIUMS AND SIMILAR CHARGES UPON THE PREMISES SUBJECT THERETO; ANY DEFICIENCY BECAUSE OF THE INSUFFICIENCY OF SUCH ADDITIONAL PAYMENTS SHALL BE FORTHWITH DEPOSITED BY THE MORTGAGOR WITH THE MORTGAGEE UPON DEMAND BY THE MORTGAGEE. ANY DEFAULT UNDER THIS PARAGRAPH SHALL BE DEEMED A DEFAULT IN
