Sixty-Seven and 66/100-----(\$ 67.66) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently Sixty-Seven and 66/100-----(\$ 67.66

extended, will be due and payable. 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Walker Springs Road, being known and designated as Lot #31 of a subdivision known as Coral Ridge, according to a plat prepared by Piedmont Engineering Service, dated March 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 119, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Walker Springs Road, joint front corner Lots #31 and #32, running thence along the line of these lots, S. 3-50 W. 180.6 feet to an iron pin in the line of Lot #30; thence N. 86-10 W. 90.0 feet to an iron pin on the eastern side of Coral Drive; thence along the eastern side of Coral Drive, N. 3-50 E. 150.6 feet to an iron pin at an intersection, which intersection is curved, the chord of which is N. 47-17 E. 36.3 feet to an iron pin on the southern side of Walker Springs Road; thence along the southern side of Walker Springs Road, S. 89-15 E. 65.0 feet to an iron pin, point of beginning; being the same conveyed to me by C. S. Willingham, as Trustee for J. Claude Hale, W. N. Leslie and C. S. Willingham by deed dated March 11, 1964, to be recorded herewith."
