MORTGAGE OF REAL ESTATE COUNTY OF GREENVILLE To All Whom These Presents May Concern: I. Harold R. McGee, of Greenville County, SEND GREETINGS: WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-Eighteen Thousand and No/100--VILLE, in the full and just sum of <u>Eighteen Thousand and No/100-----(\$.16,000.00</u>) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of One Hundred Fifty-One and 90/100-----(\$ 151.90) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable. 15 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeast corner of Earle and Rutherford Streets in the City of Greenville, being known and designated as Lot #1 on plat of M. E. Latimer land made by W. D. Neves, Engineer, in July 1919 and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast corner of the property line of Earle and Rutherford Streets and running thence with the line of Rutherford Street, S. 2-10 W. 65 feet to an iron pin, corner of Lots #1 and #2; thence with the line of Lot #2, S. 85-15 E. 170 feet to an iron pin in the line of Lot #4; thence with the line of Lot #4, N. 2-10 E. 65 feet to an iron pin on Earle Street; thence with said Earle Street, N. 85-15 W. 170 feet to the beginning corner; less, however, that portion of the above-described lot conveyed by E. Inman, Master, to the City of Greenville, South Carolina, for the purpose of widening Rutherford Street as shown by deed recorded in Deed Vol. 389, at Page 68, R. M. C. Office for Greenville County; being the same property conveyed to me by John E. Stathos by deed dated February 9, 1962, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 692 , at Page 95 ."
