All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about THREE miles northwest if Greer, S. C., lying on the west s side of a new dirt road and being the same property conveyed to me this day by deed from Marie S. Will's and Jake A.
