All that piece, parcel or lot of land located in Greenville County, State of South Carolina situate, lying and being on the northern side of West Parker Road and known and designated as Lot 2 according to a plat entitled Monaghan Subdivision dated August 9, 1954 by Piedmont Engineering Service recorded in the RMC office for Greenville County in Plat Book GG at pages 86 and 87 and having, according to said plat, the following metes and bounds, to wit:
