NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Putman Road, Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as Lot No. 1 as shown on a plat of Property of J.K. Keller, prepared by W.J. Riddle, dated April, 1948, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book U at page 97, said plat being a resubdivision of the greater part of Lots Nos. 23 and 24 as shown on a plat of Farr Estates, prepared by Dalton & Neves, dated July, 1941, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book M at page 19, and having according to the first mentioned plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Putman Road at the joint front corner of Lot No. 1 and Lot No. 25 of the Farr Estates, and running thence with the line of Lot No. 25 of the Farr Estates S. 30-30 E. 270.2 feet to an iron pin at the joint corner of Lots Nos. 1 and 2; thence with the line of Lot No. 2 N. 82-22 W. 262.5 feet to an iron pin on the Southeastern side of Putman Road; thence with the curve of the Southeastern side of Putman Road, the chord of which is N. 0-38 E., 79 feet to an iron pin; thence continuing with the curve of the Southeastern side of Putman Road, the chord of which is N. 32-10 E., 79 feet to an iron pin; thence still continuing with the curve of the Southeastern side of Putman Road, the chord of which is N. 57-0 E. 95.5 feet to the point of beginning.
