"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Laurens Road, at the southern corner of the intersection of Laurens Road and Bleckley Avenue, being shown and designated as Lot No. 5, Block A, Fair Heights, recorded in Plat Book F at page 257, and described as follows:
