NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville** in **Chick Springs Township**, shown as Lot 29 on plat of **Clearview Acres** recorded in plat book **MM**, page 168 and having, according to said plat, the following metes and bounds to-wit:

Beginning at an iron pin on the Southern side of Clearview Circle at the corner of Lot 30; thence S. 3-15 W. 175 ft.; thence N. 86-45 W. 100 ft.; thence N. 3-15 E. 175 ft. to an iron pin on the Southern side of Clearview Circle; thence with said Circle S. 86-45 E. 100 ft. to the point of beginning.
