All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Thrift Street (formerly A Street), Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 5 according to a survey of Property of T.P. Raines, prepared by George Ellis, dated September 28, 1939, and having the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Thrift Street (formerly A Street), which iron pin is located 310 feet, more or less, in a Northeasterly direction from the Southeastern corner of the intersection of Worley Road and Thrift Street at the joint front corner of Lots Nos. 4 and 5, and running thence with the line of Lot No. 4 in a Southerly direction 150 feet to an iron pin; thence in a Northeasterly direction 50 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 in a Northerly direction 150 feet to an iron pin on the Southeastern side of Thrift Street; thence with the Southeastern side of Thrift Street in a Southwesterly direction 50 feet to the point of beginning.
