TO ALL WHOM THESE PRESENTS MAY CONCERN: Jack Deskins and Hazel R. Deskins

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as a

portion of Lot 358 and a portion of Lot 359, of a subdivision known as Botany Woods, Sector VII, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book YY at pages 76 and 77 and having the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern side of Cherokee Drive, 235 feet from the point where Cherokee Drive begins its intersection with Edwards Road, and running thence with the southwestern side of Cherokee Drive N. 32-49 W. 140 feet to a point on front lot line of Lot 358; thence on a new line through Lot 358, S. 57-11 W. 200 feet to a point in the rear line of Lot 358; thence S. 32-49 E. 140 feet to a point in rear line of Lot 359; thence in a new line through Lot 359, N. 57-11 E. 200 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
