WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **in Butler Township,**

known and designated as Lot No. 19 of Block G of Fair Heights, as shown on plat recorded in Plat Book "F" at Page 257, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Brookdale Avenue, at the joint front corner of Lots Nos. 19 and 20, and running thence along the line of Lot No. 20, N. 58-40 W. 150 feet to a point at the joint rear corner of Lots Nos. 15 and 16; thence along the rear line of Lot No. 16, S. 31-20 W. 50 feet to a point, joint rear corner of Lots Nos. 16 and 17; thence along the dividing line of Lots Nos. 18 and 19, S. 58-40 E. 150 feet to a point on the western side of Brookdale Avenue; thence along the western side of Brookdale Avenue, N. 31-20 E. 50 feet to the beginning corner.
