"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as lot No. 118, Section D, as shown on a plat of property of Mountain View I and Co. recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "/" at page 396-397 and having the following metes and Lounds, to-wit:
