All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, at the Southeast intersection of Washington Avenue and Peachtree Street, and being known and designated as lot no. Twenty-eight (28) of the Nona Harris Squires Subdivision as shown on plat prepared by Piedmont Engineering Service dated Feb. 9, 1948 and which plat has been recorded in the R. M. C. Office for said County in Plat Book S, page 151, and having the following courses and distances, to-wit: Beginning at an Iron Pin at the Southeast intersection of Washington Avenue and Peachtree Street, and running thence with the East side of Washington Avenue S.22-10 E.65.5 feet to an Iron Pin at the joint front corner of lots nos. 28 and 29 as shown on said plat, thence with the joint property line of said two lots N.71-00 E.200 feet to an Iron Pin at the joint rear corner of lots nos. 8, 9, 28 and 29 as shown on said plat, thence with the joint property line of said lots nos. 9 and 28 N.22-10 W.65.5 feet to an Iron Pin on the South side of Peachtree Street, thence with the South side of Peachtree Street S.71-00 W.200 feet to the beginning point.
