C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, **Butler** Township, on the western side of the public road leading into or through the lands of J. R. Green and for the U. S. Government, and near Enorse River, designated as lot #9 on plat of the E. M. Dill property, prepared by H. S. Brockman, Surveyor, November 29th, 1945, and having the following courses and distances, to wit:-

BEGINNING at the joint corner of lots 9 and 10 in the center of the said public road, and runs thence therewith N 16-45 E 200 feet to the corner of lot no. 8; thence as the dividing line between nos. 8 and 9 lots, N. 73-15 W two hundred and twenty five (225) feet to an iron pin on the line of Lot no. 12; thence with the line of no. 12 lot, S 16-45 W two hundred (200) feet to the corner of lot no. 10; thence as the dividing line between lots 9 and 10, - S 73-15 E two hundred twenty five (225) feet to the beginning corner, and containing 1.03 acres; and bounded North by lot no. 8; East by lots no. 4 and 5, separated therefrom by the said road; South by lot no. 10 and west by lot no. 12.
