Twelve Thousand Five Hundred and no/100----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, situate on the Southern side of Cope Circle and being shown and designated as Lot 5 on plat of Cope Heights, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Cope Circle, joint front corner of Lots 5 and 6; thence with the line of Lot 6, S. 25-05 E. 150 feet to a pin; thence N. 64-55 E. 183 feet to rear corner of Lot 4; thence with line of Lot 4, N. 58-49 W. 197.8 feet to pin on Cope Circle; thence with the curve of Cope Circle 43.8 feet to a pin; thence continuing S. 64-55 W. 31.6 feet to the point of Beginning.
