Brockman, Surveyor January 15, 1936, the following metes and bounds; to wit:

BEGINNING at an iron pin on the north side of U.S. Highway No. 29 and running thence with the north side of said highway North 88-30 East 87.5 feet to an iron pin in the center of a new 25-foot street; thence along the center of said new street, North 1-30 West 187.5 feet to an iron pin; thence South 88-30 West 87.5 feet to an iron pin; thence South 1-30 East 187.5 feet to the beginning corner.

A strip 12.5 feet wide with a depth of 187.5 feet along the eastern edge of the above described property is used for street purposes and is subject to an easement for the use as a street.
