"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, about one mile southeast from the Jordan High School and on the northeast side of the jordan Road, bounded on all sides by lands of T.S. Sloan and said Jordan Road, containing two (2) acres, more or less, and having the following courses and distances:

BEGINNING at a point in the center of the Jordan Road (stake on bank of road), corner with T.S. Sloan, and runs thence along the center of said road, N. 41-00 W. 420 feet to a point (stake on the bank of the Jordan Road), corner with T.S. Sloan; thence N. 49-00 E. 210 feet to a stake; thence S. 41-00 E. 420 feet to a stake; thence S. 49 W. 210 feet to the beginning corner.
