In hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situated on the south side of State Highway No., 135, near Washington Baptist Church, in O'Neal Township, containing (1.50) acres, more or less, and being a portion of the Enoch Howell Estate, and shown on a plat thereof, by H. S. Brockman, Surveyor, dated June 4, 1951, recorded in Plat Book "AA", page 111, R. M. C. Office for Greenville County, and having the following courses and distances to wit:-

BEGINNING on an iron pin, bank of McAbee's land; thence along the line of McAbee's land S. 76-16 E. 351 feet to an iron pin; thence N. 29-32 E 137.8 feet to an iron pin; thence N. 48-29 W., 281.9 feet to an iron pin, on bank of road, point of beginning. This is a portion of that land conveyed to Frank Lindsey and Annie A. Lindsey by deed recorded in Deed Book 562 at page 16 in the R. M. C. Office for Greenville County.

This is the same property conveyed to James Arnold Campbell by Frank Lindsey and Annie A. Lindsey by deed dated April 16, 1960 and recorded in Book 648 page 365.

W. 187.8 feet to an iron pin on line of Lot No. 43; thence with line of that lot, N. 60-35

E. 141 feet to an iron pin, joint corner of Lots Nos. 41, 42 and 43 on said plat; thence with the common line of Lots Nos. 41 and 42, in a slightly southeasterly direction 210.5 ft. to an iron pin on the margin of Holliday Road; thence along and with the margin of said road, S. 32-55 W. 44 feet, S. 49-23 W. 72 feet, S. 54-20 W. 85.8 feet and S. 60-33 W.
