WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -Thirty-Six Thousand Five Hundred and No/100--
(\$ 36,500.00 ), with interest thereon at the rate of Five & One-Half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the eastern side of Montrose Avenue (formerly Babb Avenue) in the City of Greenville, being the western portion of lot 37, as abown on a plat of the Estate of Tully P. Babb, recorded in Plat Book QQ at Pages 162 and 163, and described as follows:
