WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of the State of North Carolina, hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Nine Thousand Two Hundred and  
No/100----- Dollars (\$9,200.00), with interest from date at the rate  
of five and one-fourth per centum ( 5-1/4 %) per annum until paid, said prin-  
cipal and interest being payable at the office of Cameron-Brown Company, 900 Wade  
Avenue in Raleigh, North Carolina  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Fifty and 88/100----- Dollars (\$ 50.88),  
commencing on the first day of December, 1964, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of November, 1994.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

ALL that lot of land with improvements situate on the eastern side of Camelot  
Lane, off the Welcome Road, in Greenville County, South Carolina, being known  
as Lot No. 10 on a Plat of the Subdivision of the Property of J. E. Strickland,  
made by J. C. Hill, R. L. S., dated August 6, 1954, and being shown on a more  
recent Plat thereof made by R. K. Campbell, Engineer, dated October 1964, and  
recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat  
Book HHH, Page 101, reference to which is hereby craved for the metes and  
bounds thereof. This property faces on the eastern side of Camelot Lane for  
a distance of 70 feet and runs back in parallel lines for a depth of 171 feet.
