ALL that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, situate, lying and being on the South side of Lowndes Hill Road and being known and designated as LOTS NOS. 23, 24 and 25 on plat of East Lynne, made by Dalton & Neves, June 1931, recorded in the RMC Office for Greenville County in Plat Book H, at page 195 and described as follows:
