"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

ALL that certain piece, parcel, or tract of land in Oaklawn Township, Greenville County, South Carolina, about two miles south of Pelzer, on the east side of Holland's Ford Road, being a portion of Tract 10 of the plat of the property of the Estate of Narcissus N. Anderson, recorded in the R.M.C. Office for Greenville County in plat book E, page 74 to 77. This tract 10 is also shown of a plat of the Property of R.E. Evans prepared by J.C. Hill on May 18, 1950. The tract herein conveyed is described as follows:
