WHEREAS, WE the said SUNNY SUTTON AND FAYE B. SUTTON
in and by <u>OUR</u> certain promissory note in writing, of even date with these Presents <u>ARE</u> well and truly indebted to CAMERON-BROWN COMPANY, a corporation chartered under the laws of the State of North Carolina, in the full and just sum of $SEVENTEEN$ THOUSAND FIVE HUNDRED AND No/100 (\$ 17,500.00) DOLLARS, to be paid at its office in Raleigh, N. C., or at such other place as the holder
of the note may from time to time designate in writing, with interest thereon from date hereof until maturity at
the rate of $FIVE\ AND\ ONE-HALF(5.1/2.76)$ per centum
per annum, said principal and interest being payable in 360 instalments as follows:
Beginning on the $\frac{1sT}{MONTH}$ day of $\frac{MAY}{MONTH}$ , 19.65, and on the $\frac{1sT}{99.40}$ day of each year thereafter the sum of \$ 99.40, so be applied on the interest and principal of said note, the unpaid balance of said principal and interest to be due
to be applied on the interest and principal of said note, the unpaid balance of said principal and interest to be due
and payable on the $\frac{1ST}{40}$ day of $\frac{APRIL}{40}$ , 19.95; the aforesaid $\frac{MONTHLY}{40}$ payments of \$99.40 each are to be applied first to interest at the rate of $\frac{FIVE}{4ND}$ ONE—
$HALF$ = ( $5\frac{1}{8}$ %) per centum per annum on the principal sum of \$ 17,500.00 or so much thereof
as shall, from time to time, remain unpaid and the balance of each <u>MONTHLY</u> payment shall be applied on account of principal.
All instalments of principal and all interest are payable in lawful money of the United States of America; and n the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) percentum per annum.
And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgage promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.
