Township, on the north side of the Dual-lane Highway No. 29 and on the east side of Dill Avenue, about three miles westward from the City of Greer, designated as Lots Nos. 1 and 2 of the W.E. McIntyre property according to survey and plat thereof by H.S. Brockman, Surveyor, dated Plarch 16, 1939, and having the following courses and distances, to-wit:
