"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, located on the west side of Lanford Street in the City of
Greer, being known and designated as Lot No. 37 on a plat of WESTMORELAND
CIRCLE made by W. J. Riddle, Surveyor, dated December, 1921, and
retraced and checked by H. S. Brockman, Registered Surveyor, July 21,
1936, recorded in the R. M. C. Office for Greenville County in Plat
Book T, pages 198, and having the following courses and distances:

BEGINNING at a stake, corner of Lot No. 36 on Lanford Street, and running thence N. 17-40 E. 50 feet with Lanford Street, corner of Lot No. 38; thence N. 62-20 W. 189.7 feet with line of Lot No. 38 to a stake on Green Street; thence with Green Street, S. 13-00 W. 50 feet to corner of Lot No. 36; thence with line of Lot No. 36, S. 62-20 E. 185.7 feet to the beginning corner.

ALSO, all that other parcel or lot of land adjoining the above described property, situated on the west side of Lanford Street and on the east side of Green Street, being known and designated as Lot No. 38 on plat of WESTMORELAND CIRCLE, referred to above, and having the following courses and distances:

BEGINNING on an iron pin at edge of Lanford Street, the southeastern corner of said lot, and runs thence along the edge of Lanford Street, N. 17-40 E. 50 feet to an iron pin, corner of Lot No. 39 on said plat; thence N. 72-20 W. 193.5 feet to an iron pin or stake on Green Street; thence along the edge of Green Street, S. 13-00 W. 50.1 feet to an iron pin or stake; thence along the line of Lot No. 37, S. 72-20 E. 189.7 feet to the beginning corner.
